In accordance with Articles 13(1-2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, known as GDPR), we inform you that:

3. Purpose and legal basis for processing. Your personal data will be processed based on: - Article 6(1)(b) and (c) of the GDPR - the processing of data is necessary for the conclusion or performance of a contract or for taking pre-contractual measures.

4. Your personal data will be stored for a period of 10 years from the end of the lease or tenancy. Your personal data - in the case of concluding a lease agreement with you - financial documents will be stored for a period of 5 years from the beginning of the reporting year following the year in which the agreement was completed - in accordance with applicable law and accounting standards. - Article 6(1)(f) of the GDPR - the legitimate interests of the Controller, in particular, the assertion or defense against claims, will be stored for a period of 3 years from their receipt or the performance of the last action with personal data.

5. The period of processing your personal data is related to the above-mentioned purposes of their processing. For this reason, personal data will be processed for the period during which the law requires the Controller to keep data, or for the limitation period of any claims, the resolution of which requires data.

6. Rights of the data subject. In accordance with the principles set out in the applicable personal data protection regulations, you have the right to access your data and obtain their copy, the right to correct (rectify) data, the right to delete, restrict processing, or object to processing, the right to data portability, and the right to lodge a complaint with the relevant supervisory authority.

7. Data recipients.
